

## Bristol Lakes Bulletin February 1, 2020



### TIME FOR ELECTIONS

On January 13, 2020, Campbell Property Management mailed us its first notice informing us of our Annual Meeting, scheduled for March 26, 2020. Included with that mailing was a NOTICE OF INTENT form to place YOUR NAME on the ballot for the HOA 2020 Election of Directors.

If you would like to serve on the Board of Directors, you have until the **Deadline** of **February 14, 2020** to submit your form to Campbell Property Management, 9897 Lake Worth Rd Suite 304 Lake Worth, FL. 33467 or e-mail to Iteets@campbellproperty.com. CPM will ask you to submit a resume. When second notices are mailed, they will contain a list of candidates on the ballot and their resumes, as well as other pertinent information relating to the Annual Meeting.

If you are considering a run for a seat on the Board, it is important to state your intent by completing the form NOW. The latest Florida Statutes governing HOAs, (which have now been incorporated into the pending revision of our By-Laws) allows candidates to be nominated in advance of the Annual Meeting, as NO NOMINATIONS FROM THE FLOOR WILL BE ALLOWED.

Two of our Board members have announced that they will not stand for re-election. Although our Homeowners Documents state our Board of Directors can function with as few as 3 people, if YOU step up and volunteer to fill the gap, the Board will be able to continue functioning at its highest capacity (5). Your ideas are important and your voice should be heard. If you believe you can offer the Community a valuable service by serving on the Board of Directors, NOW is the time to give your NOTICE of INTENT and submit your form to Campbell Property Management.

### PBSO WILL BE PATROLLING BRISTOL LAKES

With the signature from Sheriff Bradshaw, Bristol Lakes roads will be patrolled by the Sheriff's Dept. This means that sheriff cars will be able to patrol and enforce rules of the road and offer visibility to deter crime. This also means that residents may be ticketed for any violation in the States Highway Safety and Bristol Lakes rules and regulations.

### **COMPLIANCE COMMITTEE**

Compliance Committee makes rounds of the community once a month. If you receive a notice of a roof or driveway that needs attention or any other property maintenance need, please comply. If there are reasons you cannot comply, notify Campbell Property Management with a detailed reason and approximate completion date. If you have not responded, or the violation is not corrected after being sent 3 letters, and no letter has been sent to the Management Company explaining your needs, a Notice will be sent to you for a Grievance Committee hearing. Regardless of whether a fine is levied at the outcome of the hearing, you will be charged a \$35.00 dollar administration fee. Maintaining our homes enhances the value of living in Bristol Lakes for all of us. Thank you for your cooperation.

### PROPOSED CAPITAL CONTRIBUTIONS

At the January Board meeting there was a discussion about starting a Capital Contribution for new home buyers to our community. We need to amend our documents to charge a new owner a capital contribution. If the community approves by a 51% vote we would be able to charge an amount (Such as \$1,000 dollars) to be paid by the new buyer and will keep our reserve funded. The buyer already shares the previous owners contributions when purchasing the home, but this added amount would help keep our reserves **as** a backbone of our community. At the time of this article our reserves are \$263,000 and these are reserved for Paving, Storm Drain Cleaning, Storm Clean-up, Perimeter Wall, Landscaping, and Guard house, along with a general reserve. A solid reserve fund enables our community to operate without an assessment, and a buyer who is aware of this should be willing to buy here in Bristol Lakes.

### **IGUANAS PROJECT**

The Board approved a contract with Redline Iguana Removal to visit once a month, and more if needed, to catch the invasive and destructive iguanas who have invaded our community. Redline has been on TV often explaining the problems community are having with the iguanas. If you have seen an iguana please fill out a sighting form on our web site www.bristollakes.com

### THE CANAL PROJECT

Most of the Ficus has been removed except the first 200' from Hagen Ranch Road. We are keeping these in until Bugaway starts removing the Ficus stumps. This will give the homes near Hagen Ranch Road additional weeks of quiet and privacy. Bugaway plans to start removing stumps near the end of the week beginning February third. This phase of the project will take about 2 days. After the stumps are removed fence repairs will begin. We are estimating the end of February to have these steps completed.

During stump removal and fence repairing there will be workers in your backyards, Please be aware of this and keep anything of value away from the work area. Also keep dogs away from the workers. The workers should stay close to the work area. Let us know if this is not the case. Sorry we have to give this warning, but when the job is completed your property values should go up.

The new Arboricolas should be planted by the end of March. We are planning to have all of these on the canal side of the fence, none on the yard side of the fence. No trees will be removed during this project. The county wants us to bring the buffer up to code along the canal by replacing the trees we take out and adding additional trees every 60 ft. Only 20 percent of these trees can be Palms. The Palms have to be planted in groups of three. All other trees have to be in the shade tree category. To bring the trees up to code would be cost prohibitive, therefore we are not including them in this project. Bugaway has agreed to keep the existing trees neatly trimmed to help reduce the debris in your yards.

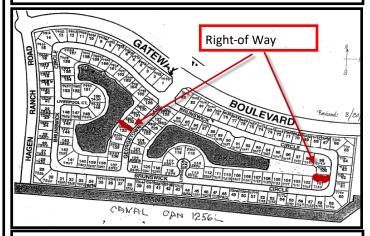
The board is working very hard to improve the landscaping along the canal, we appreciate your cooperation.
