NEW GARBAGE REGULATIONS

On June 25th, we sent out an E-Mail Blast informing you of the new Garbage/Recycle/Trash features coming October 1, 2019. If you did not receive it you can see and read it on our website www.bristollakes.com. We have asked Bugaway to let the shrubs or bushes concealing the garbage cans grow to a height of 48 inches as the new cans are 46 inches. If you plan to store the new garbage container outside, start a barrier so you cannot see the can from the street. You may want a shrubbery or fence type. Be sure to get ARC Approval. The new cans will be Light Grey in color, according to the SWA.

IMPROVEMENTS

In a continuing effort to keep our front entrance inviting to all who visit us, we will be restriping our entrance pavements markers. The work should start in early July.

We are getting new flowers on Brunswick and Georgetown and the garden on Gateway and Hagen Ranch. A meeting is planned with TSM, the Landscaper who does the entrance way, to review the flower and shrub placement and irrigation.

FIREWORKS

The PBSO is reminding all that anything fired into the sky is ILLEGAL without a permit in PBC. Applications are available from PBC Fire Rescue, but usually are required 30 days before the event. Sparklers and noisemakers are legal, but still carry the risk of injury. Please celebrate safely, and we will all have a Happy July 4th.

FRAUD

As you all know, scams are everywhere, and recently it was discovered that an email address had been 'hacked'. This incident was not in their control and it unfortunately affected a resident of our Community. The resident responded to a bogus/scam request for **\$500 in Google Play gift cards**. The person who was "hacked" had nothing to do with this scam request, nor would they ever consider doing so. Please double check incoming emails/email addresses to be positively sure of who you are emailing responses to! If in doubt, don't answer or download any materials. We 'preach' at our BLHOA BOD & Aberdeen POA meetings to be vigilant, ask questions, and if you see something, say something. It is important to know that scams like this can occur to anyone right in our own backyard.

STOP THE BLEED

Many Communities and Organizations are presenting this program for their Communities and their Organization. If we can get enough residents to sign up for a class we can obtain a professional Instructor to give the class. You will learn to first call 911, then Compress (find where the bleeding is coming from), then apply firm steady pressure. Tourniquet if the bleeding does not stop place a tourniquet 2-3 inches closer to the torso from the bleeding. You may need a second tourniquet.



OCTOBER SWA REGULATIONS

Debris piles that exceed 6 cubic yards will not be serviced. They will be tagged and it will be the resident's responsibility to arrange for removal, either by hauling it to a permitted disposal facility, making arrangements with a private hauler, or contracting with SWA for an estimate at \$8 per cubic yard. Any pre-existing piles exceeding that 6 cubic yard limit will not be eligible for collection as of October 1st 2019.

Debris piles other than Palm fronds and tree branches, such as leaves, tree and hedge trimmings, pine needles etc. must be containerized, tree branches and palm fronds should be neatly stacked in a pile that does not exceed 6 cubic yards. Branches should be cut into pieces that are no more than 6 feet long, 6 inches in diameter and weigh no more than 50 lbs. each. Palm fronds can be any length

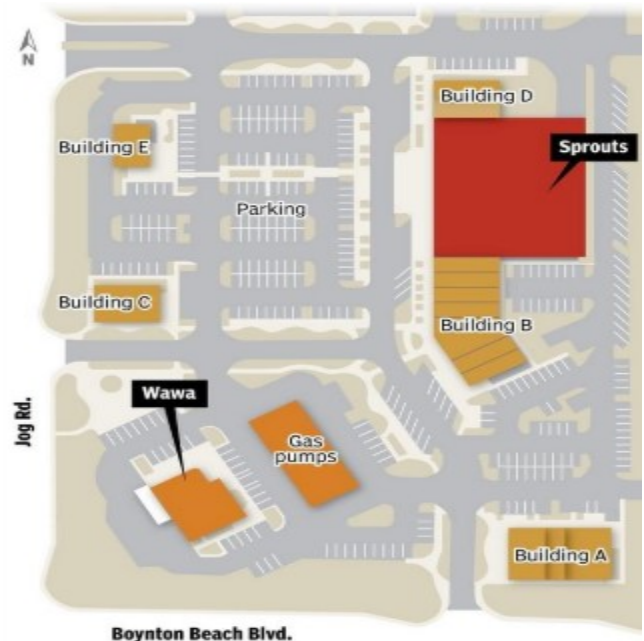

New Plaza at Jog & Boynton Beach Blvd

Main Street at Boynton, a development on the northeast corner of Boynton Beach Boulevard and Jog Road will include a 30,000-square-foot Sprouts Farmers Market, a 16-bay Wawa with a 6,200-square-foot convenience store and a two-story, 113,700 square-foot assisted living facility that will house 158 residents in 130 units. The zoning is currently commercial but the developers are seeking a change to multiple use planned development.
