"All vehicles parked within the SUBJECT PROPERTY must be in good condition and repair and no vehicle which does not contain a current license plate or which cannot operate on its own power shall be parked within the SUBJECT PROPERTY outside of an enclosed garage for more that 24 hours, and no major repair of any vehicle shall be made on the SUBJECT PROPERTY."
